 - Past Boards have approved the Budget in February which has allowed it to go before Barrie City Council for final approval in March.
 - It was discussed having the budget process for next year's budget begin in October and November. This would allow the Board to move into January with a plan moving forward.
- o Mr. Randy Aylwin also inquired about the status of Downtown Barrie Annual Report.
 - The 2018 Annual Report is currently being drafted. It will provide a year in review summary of 2018 along with having a summary of the 2019 Budget on the back page of the document.

• CULTURE & HERITAGE EVENTS -

• Discussion:

- The Board discussed the 'flexibility' or 'malleability' of the Budget once it has been approved.
 - It was noted that if an opportunity was presented that the Board wanted to be apart of there is 'flexibility' with the budget to make it happen even after the budget is approved.
- The Board also discussed the possibility of sponsorships to fill the funding gaps within the 'Culture & Heritage Events' budget.
- Councillor Clare Riepma inquired about if the 2019 Budget mirrored the BIA 2018 Budget.
 - It was noted that the programs that were successful in 2018 are continuing in 2019. Some 'Event Sponsorships' are not carrying forward because they are no longer a good fit and/or the BIA's dollars we can invest in something better.
 - Managing Director noted that when working with limited funds it is important to consider where they are best utilized. Two (2) examples of successful programs:
 - 1) Patio Program combines a radio promotional marketing campaign to a physical entity within the public realm (i.e. the Patio) which also addresses safety aspects with more people Downtown.
 - 2) Community Connect Events While seemingly small grass roots events, they provide the BIA with thousands of email contacts which the BIA is loading into a database for future promotional outreach at no cost.
- Councillor Riepma inquired about funding amount in the BIA 2019 Budget for programming of Meridian Place.
 - The Downtown Barrie (BIA) has the expanded the 'Lawnchair Luminata' umbrella series of events item in the budget to assist with programming Meridian Place. The goal is to use the umbrella series to program Meridian Place five out of seven days a week. This does not include other third party event programming.
 - The goal is to support/supplement the programming of Meridian Place through sponsorship.
 - The Meridian Place Working Group is also looking at grants to assist with funding programming and accessing the 'Accommodation Tax' funding.
- The Board expressed a desire to hold another Special Meeting solely to be brought up to speed on the history, status, and the future of Meridian Place & Memorial Square.
 - Managing Director Stevens gave a brief overview of the following:
 - a history of the Meridian Place & Memorial Square project,
 - the opportunities for operation of the space (i.e. other similar parks/venues best practices),
 - the status of the space's transition from park to venue,
 - some details about the partnership with the City,
 - an overview of the Meridian Place Working Group
 - an overview of the overall model for programming and building out the assets for the space.

- Discussion:
 - Councillor Keenan Aylwin inquired about the Security Cameras. He noted Barrie City Council had approved in the City Budget an increased contribution to the Barrie Police Service for capital and operating. He asked how the BIA's Security Camera investment fits into what the City is paying.
 - The Downtown Barrie (BIA) is currently in year six (6) of their 10-year commitment towards the cameras from original installation.
 - It was noted that the new amount the City has allocated must be for the replacement.
 - The Board also discussed who is monitoring the cameras. It was noted that the cameras are monitored by Barrie Police.
 - o Ms. Tracey Baker inquired about the amount allotted for 'wayfinding signage' and 'Christmas decor'?
 - Managing Director Stevens noted the opportunity as an organization to project out capital opportunities so that the budget can align according so that we can make these investments; as well as while at the same time looking at assessment increases through new development that provide opportunity.
 - The Board discussed why the 'Beautification Budget' it so low?
 - It was noted because of waiting for the Streetscape Project to begin.
 - Mr. Ing inquired if the Board approves the Budget what leverage will the BIA have with the City in regards to the Streetscape moving forward?
 - Managing Director Stevens noted that those numbers are 'null in void' and that the Streetscape investment won't happen in 2019.
