Owen Street Closure and Bell Utility Work

**January 21, 2020** 

# Work on Owen Street (Collier St. to Dunlop St.) taking place from late January to March, 2020

The project includes the demolition and rebuilding of an ageing Bell maintenance hole.

This work will require the closure of Owen Street from Collier Street to Dunlop Street for four to six weeks starting January 22, 2020. Owen Street will remain open for local traffic and pedestrians only. Dunlop Street will remain open in East/West direction.

Following the Bell utility work the Owen Street intersection, including Dunlop Street, will be closed until June 2020.

### Why Is This Work Being Undertaken?

The goal of this project is to upgrade the Bell maintenance hole to ensure that the underground infrastructure is up to date before the next phases of the Dunlop Street Construction Project begin (scheduled to begin in March 2020). #### Will My Services Be Affected?

Sanitary sewer, water, hydro and gas services should not be affected by the construction, barring any unforeseen circumstances. Your communication services (phone, internet and/or cable TV) should also not be affected.

If you experience a service disruption at any time, please report it to your service provider immediately so that service can be restored in a timely manner.

#### **Curbside Garbage Collection**

Garbage pickup will not be affected by construction. On your normal curbside collection day, area residents are asked to place all garbage, organics, recyclables, and yard waste materials at the front of the property as usual by 4:30 a.m. The construction contractor will remove these items and take them to the outside of the construction zone for pickup by the City's waste contractor. Garbage cans, organic bins, and recycling boxes will be returned to the property later that day. Please mark your address on all of your containers.

#### **Snow Maintenance**

The City of Barrie's Operations
Department will continue to do snow
removal on this part of Owen Street
during construction. The regular snow
clearing standards will be maintained.

#### **Access to Properties**

There will be a full road closure and only those motorists requiring access to the properties/businesses located within this road closure area may have access. Detour signage will be in place to help direct motorists around this local closure.

On-street parking spaces will still be available, but there may not be as many spaces open during construction.

Vehicle access to properties/ businesses within the construction limits will be maintained during the construction period.

Pedestrian access to properties will be maintained throughout the duration of the construction.
