BY-ELECTION DATA:

190 votes were cast (approximately 38% of the BIA membership participated in this by-election).

133 votes were proxy votes.

A maximum of 64 and a minimum of 40 of these proxy votes may be deemed ineligible in terms of non-corporate (given that some businesses may in fact be corporate members and that this was not indicated on the Voting Certification form)

All votes were cast by secret ballot.

Non-proxy votes cast totalled 57 (190-133), but it is not known who was voted for on those 57 non-proxy votes as they were not distinct ballots from the proxy votes and ballots were cast confidentially.

115 votes were duplicate proxy votes (i.e. John Doe cast votes as a proxy for two or more members).*

-	Colin Hassey	24	(22 corporate / 2 potentially non-corporate)
-	Name Redacted #1	21	(19 corporate / 2 potentially non-corporate)
-	Paul Lynch	1	(1 corporate)
-	Name Redacted #2	8	(8 potentially non-corporate)
-	Daniela Fuda	4	(2 corporate / 2 potentially non-corporate)
-	Cait Patrick	2	(2 potentially non-corporate)
-	Name Redacted #3	3	(3 corporate)

^{*}These numbers reflect the one allowed vote that each candidate cast as a member of the BIA, with the exception of Colin Hassey, Name Redacted #1 and Name Redacted #2 who do not have an inherent vote as they are not members of the BIA.

Of the 6 candidates with the most votes, the candidate with the least amount of votes was Cait Patrick with 128. If all 64 of the potentially ineligible proxy votes were subtracted from her total, she would have won 64 votes - 33 more than the 7th place candidate. The results would appear as:

If Jason's, Colin's, Name Redacted #1, Paul's, Daniela's and Cait's duplicate proxy votes were removed from their individual totals, the results would appear as:

-	Jason Ing	101
-	Daniela Fuda	137
-	Rob Hamilton	137
-	Paul Lynch	111
-	Colin Hassey	108
-	Cait Patrick	126

Consideration should be given for whom Name Redacted #2 and Name Redacted #3 cast duplicate proxy votes, however, this can't fairly be determined.

If it is safe to assume that Jason, Colin, Name Redacted #1, Paul, Daniela and Cait all cast duplicate proxy votes for the six candidates who won the most votes, then a total of 104 should be removed from their vote counts, resulting in the following:

-	Jason Ing	49
-	Daniela Fuda	37
-	Rob Hamilton	33
-	Paul Lynch	29
-	Colin Hassey	28
-	Cait Patrick	24

In order to remain fair, the method above (which removes 104 votes from the total votes of the six candidates with the most votes) should also be applied to the remaining candidates, which would be difficult to do.
