#### **2020 BUDGET**

The board discusses reducing the amount of the proposed 2020 Downtown Barrie Business Association (BIA) budget.

Mr. Lynch proposes reducing the budget by 25% to approximately \$556,000.00.

The board discusses potential issues such as not being prepared for a quick recovery from the COVID-19 pandemic and possibly reducing the budget even further.

Councillor Jim Harris notes that Ms. Dawn McAlpine, General Manager, Community & Corporate Services with the City of Barrie, stated that the deadline to provide the budget is June 8th, 2020.

Mr. Lynch notes a potential pecuniary interest in voting on the office rental and maintenance line items and the Board decides to vote on that item so discussion on the proposed reduced budget can continue and remain inclusive of all board members

The Downtown Barrie Business Association (BIA) Board of Management moves a motion to approve the 2020 Downtown Barrie Business Association (BIA) budget for the Downtown Barrie (BIA) office rental and maintenance line items with costs of \$20,070.00.

Chair Hamilton moves a motion to approve the reduced 2020 budget of \$556,000.00. Seconded by Mr. Hassey

Discussion continues on the proposed reduced 2020 budget of \$535,930.00 (\$556,000.00 less the \$20,070.00 costs for the office rental and maintenance line items).

The board notes that this is an overall reduction from which specifics will be decided at a later date.

The Downtown Barrie (BIA) Board of Management moves a motion to approve the 2020 Downtown Barrie Business Association (BIA) Operational & Capital Investments Budget of \$535,930.00 exclusive of the office rental and maintenance line items.

Motion moved by: Chair Rob Hamilton Seconded by: Mr. Paul Lynch

> Vote: 11 in favour 1 opposed Approved

Councillor Morales reminds Downtown Barrie (BIA) staff that if they need to spend money, they should review with the board or executive team first.

Chair Hamilton begins discussion on his new role as Chair and his expectations of the board and staff.

Chair Hamilton asks the board to provide Ms. McKenna their availability for another meeting in the coming days.

Chair Hamilton asks that the board provide Ms. McKenna with their goals and objectives.

Chair Hamilton asks that BIA staff submit their job descriptions to him for review by Wednesday, May 27th, 2020.

The board discusses the pedestrianization of Dunlop Street and asks what the polling results were. Ms. McKenna notes that 80 submissions were received and that 68% of those submissions were in favour of the pedestrianization of Dunlop Street.

- Chair Hamilton adds that the BIA will need to program this space so that the closure is set up for success and asks Ms. McKenna that this be added to the next meeting's agenda.

Mr. Lynch asks whether it would be prudent to put any pending financial commitments (i.e. Barriston Law and the contract they were awarded for the governance review).

- Chair Hamilton says this can be added to the next meeting's agenda.

Mr. Hassey asks if there is anything the BIA can do to help the businesses who will be negatively affected by the pedestrianization of Dunlop Street.

- Chair Hamilton says that this can be added to the next meeting's agenda.
