### **MARKETING & PROMOTIONS:**

# Background:

- Executive Director Kelly McKenna reiterated her ask for the Board to allocate \$40,000.00 In the 2021 Marketing and Promotions budget towards the Rebranding, Comms Strategy, and the Website redevelopment projects.
- She also noted that in January, the BIA will no longer have a contract with Gel Agency, who is currently hosting the BIA's website. As such, she would like to have a budget in place so that we can move forward with the project.

#### o Discussion:

- Mr. Hassey noted he does not think it's the right time for a rebrand or think that it is necessary with respect to website redevelopment. He noted that the BIA should be able to achieve everything needed within a \$10,000.00 budget scope and that \$20,000.00 to redesign this website is a lot of money.
- Councillor Sergio Morales expressed concern about how a lesser budget would affect e-commerce capabilities on the website and also inquired about current hosting. Mr. Ballatyne noted concerns about what is currently being requested in the BIA's current RFP. Councillor Morales echoed Mr. Ballanyne's concerns.
- Mr. Lynch and Ms. Woolard noted that they would rather see these funds used for pedestrianization.
- In regards to the events portion of the Marketing & Promotions budget, Mr. Ing noted his concerns with the marketing of winter events given the current situation with COVID.
